Minimum Maintenance Checkups during Maintenance Visits: CCTV System - Service

provider during the each AMC visit will:

(i) Check the complete system including all cameras. Service provider will ensure that the CCTV coverage is available for main entrance of the bank, entrance to strong / safe room, cash safe, cashier cabin(s), branch manager cabin, lobby area, outside branch including parking and ATM room (If available).

(ii) Change the position of the camera in consultation with the Branch Manager and RSO, if a camera is fitted at a place where its performance is adversely affected by bright

light falling on it.

(iii) Ensure that the camera in ATM room appropriately sited inside the ATM room focused and covering the customer's face and hands transacting cash but not the ATM screen and keypad so as not to compromise on the confidentiality of the transaction.

- (iv) Ensure the settings of all cameras and DVR are in such a way without compromising the quality and required standards so as to achieve recording of 90 days minimum (180 days minimum for Locker Branch) which in future may be increased to more number of days as and when directed by the competent authority of the bank.
- (v) Ensure that the CCTV system is connected to branch UPS.
